Along with the rest of the world, I received a press release (see attached) from Perry Hooper, Jr., this afternoon regarding his announcement of (and of course, taking credit for) the flipping/switching of two Crenshaw County Democratic County Commissioners to the Republican Party in Crenshaw County, Alabama. This press release from Perry completely changes the entire agenda of a local event that the local party has worked on and planned for weeks-----a change completely unauthorized by any local party member and with no advance notice. Naturally, the press release also advised that Perry Hooper would be the emcee of this local party event, which never was the local plan. As local party chair planning this event, I early on called Harold Sachs for advice, and Harold advised that local decisions and local events were up to the local party to handle and decide.

Since Perry has pulled this same publicity seeking stunt before in other areas, there has been much discussion regarding the issue of Perry being showcased in this event. As party chair, I held a meeting where it was agreed upon by both party switchers, Commissioners Michelle Stephens and Merrill Sport, respectively, and myself, that this event would be only a local party event. Additionally, we did not feel it was appropriate to showcase Perry for a State Senate Seat (since he has stated many times, all over our Senate District, that he is running for State Senate), while alienating other Senate candidates, Will Barfoot and Ronda Walker. Our County Party will not engage in this exclusive alienating behavior in a party primary. As a result of Perry's actions, the local party will not now participate, condone, and/or sanction this event. Perry is on his own.

I wish to emphasize that this was always planned to be a local party event. The purpose was to also highlight the changing face of Crenshaw County's political landscape. Additionally, we were proud to announce the first female Republican candidate in our county's history.

Unfortunately, Perry Hooper has turned this occasion into a cheap promotional stunt to further his personal agenda. Our county party is being subjected to Hooper's wholesale, narcissistic, self-promotion, with no regard to Crenshaw County or the interests of its residents.

The attempts to hijack this event are frankly, insulting to the hard working members of our community and to the Local Republican County Party. Perry is bullying his way into the spotlight when he has been asked not to do so. It is worth noting, that Perry is attempting to speak for a county where he is neither a resident, nor an elected official. As a resident of Crenshaw County, it is asked that Mr. Hooper let us define our own values and not try to hijack us by his self-promotion.

As a result of Perry's high handed usurpation, the Crenshaw County Republican Committee will not be attending this event. We disavow and decline any participation, particularly, as Perry's press release is 180 degrees from what was planned by the local committee.



Our Probate Judge was appointed to the unexpired term of former Probate Judge Jim Perdue. However, as a result of what Perry has now done, the Judge has withdrawn from the local event and may yet now run as a Democrat. This is just another reason Hopper's brand of self-serving politics has to stop.

The local Republican Committee apologizes to Will Barfoot, Ronda Walker, and others, for any confusion these unfortunate, self-promotion tactics have caused. If we learned anything from our recent U.S. Senate election, it is that someone like Perry cannot take over and dictate to Crenshaw County, any more so than Mitch McConnell, and the Washington D.C. crowd tried to do recently in Alabama. The Crenshaw County Republican Committee will continue to provide a welcoming and inclusive environment to all Republican Candidates on an equal footing, but will not unfairly showcase one individual over others.

Like the State of Alabama, as we always have, Crenshaw County will continue to define our own values, as well as drain our own swamp.
