RE: Mandatory Release automation

Automation of the following was placed into production on May 19, 2020:

Pursuant Code of Alabama §15-22-26.2, **certain** inmates with an **offense date** of January 30, 2016 or later who have not been paroled shall be released from Alabama Department of Corrections (ADOC) custody to the supervision of Alabama Bureau of Pardons and Parole (ABPP) using a **range** based on the length of sentence. Inmates released in this manner shall be subject to "intensive" supervision under the authority of ABPP. Exclusions are listed below, and there are other factors which potentially impact the calculation of a mandatory release date.

The statutory mandatory release range for sentences:

<u>Sentence</u>	Window for	<u>r release prior to End of Sentence (EOS</u>	<u>5)</u>
5 years or less		3-5 months	
>5 years but < less than	10 years	6-9 months	
>10 years		12-24 months	

Mandatory Release shall not apply to:

- A defendant convicted of any sex offense involving a child, as defined by §15-20A-4.
- Inmates serving a life sentence.
- Inmates serving a sentence pursuant Alabama Code § 15-18-8, the Alabama Split Sentence Act.

Placement on Mandatory Release does not imply that the inmate's sentence is complete. The inmate is being released to continue serving their sentence under the supervision of the ABPP until their minimum release date (EOS).

To ensure intent of the statute is carried out in the interest of public safety, no inmate will be released until ABPP has communicated to Central Records Division that the home plan/supervision is approved, and that victim notification has been made consistent with the Mandatory Release statute.

Normal release procedures shall apply, utilizing Form C-80, "Release of Inmate", which shall only be provided by ADOC Central Records Division.

Alabama Code Title 15. Criminal Procedure § 15-22-26.2

- (a) A convicted defendant sentenced to a period of confinement under the supervision of the Department of Corrections shall be subject to the following provisions, unless the defendant is released to a term of probation or released on parole under the provisions of Chapter 22 of Title 15:
- (1) If the defendant is sentenced to a period of five years or less, he or she shall be released to supervision by the Board of Pardons and Paroles no less than three months and no more than five months prior to the defendant's release date;
- (2) If the defendant is sentenced to a period of more than five years but less than 10 years, he or she shall be released to supervision by the Board of Pardons and Paroles no less than six months and no more than nine months prior to the defendant's release date; or
- (3) If the defendant is sentenced to a period of 10 years or more, he or she shall be released to supervision by the Board of Pardons and Paroles no less than 12 months and no more than 24 months prior to the defendant's release date.
- (b) The provisions of this section shall not apply to a defendant convicted of any sex offense involving a child, as defined in Section 15-20A-4.
- (c) Prior to the defendant's release to supervision pursuant to this section, notice of such release shall be provided to the victim and interested parties through the victim notification system established pursuant to Section 15-22-36.2 and under the provisions of Section 15-22-36.
- (d) Release of an offender to supervision pursuant to this section shall be release to an intensive program under the supervision of the Board of Pardons and Paroles.
