BRIEF Narrative:
On 6/22/2020 at approximately 5:25pm, Inmate Darnell McMillian, B/216343 B-15 Imperial Gangster Disciple, approached Officer [REDACTED] in B Unit with lacerations on both his wrist and stated he was suicidal. Officer [REDACTED] escorted him to the shift office and notified Lieutenant [REDACTED]. Inmate McMillian was escorted to the Infirmary where he was examined, treated and released back to ADOC custody by Registered Nurse [REDACTED]. Inmate McMillian was evaluated in the Mental Health Building by Licensed Practical Nurse [REDACTED] who advised Lieutenant [REDACTED] that inmate McMillian was to be placed on constant observation with only a safety smock, blanket, mattress and tray/cup. At approximately 6:15pm, Officers [REDACTED], [REDACTED] and [REDACTED] were in S Unit. Officer [REDACTED] handcuffed inmate Demetris Eatmon, B/242591 S-11 Black Gangster Disciple (who was already assigned to S-11). Officers [REDACTED] and Jackson placed inmate McMillian (who was handcuffed) in cell S-11. Officer [REDACTED] removed the handcuffs from inmate McMillian. Officer [REDACTED] was in the process of removing the handcuffs from inmate Eatmon and inmate McMillian began hitting inmate Eatmon with his fist. Inmate Eatmon (who still had a pair of handcuffs), after being hit several times, began hitting inmate McMillian back. Lieutenant [REDACTED] gave both inmates several loud verbal orders to stop fighting and neither inmate complied. Lieutenant [REDACTED] drew his Aerosol Deterrent Spray, Sabre Red can #6099417, and issued several burst of spray into the cell along with several more orders to stop fighting. Neither inmate complied. Lieutenant [REDACTED] radioed for Captain [REDACTED] to come to the Unit. Officer [REDACTED] retrieved the Sabre Red Cell Buster from the cube and administered a burst into the cell with more verbal orders to stop fighting. Both inmates then complied. Captain [REDACTED] arrived in the Unit. Both inmates were handcuffed. Lieutenant [REDACTED] escorted inmate Eatmon to the Infirmary where he was decontaminated, examined and released back to ADOC

custody by Registered Nurse . At approximately 6:25pm, Officer escorted inmate McMillian to the Infirmary in a wheelchair. Registered Nurse observed that inmate McMillian was non-verbal and unresponsive. Registered Nurses , and placed inmate McMillian in the triage area and began administering CPR and utilizing the Automatic External Defibrillator (AED). At approximately 6:45pm, Captain notified Warden . At approximately 7:00pm, Warden arrived at the institution. At approximately 7:35pm, Regional Paramedic Services ambulance arrived with Paramedics and and were escorted to the Infirmary. At approximately 7:49pm, Paramedic was on the phone with UAB Medical Doctor who pronounced inmate McMillian deceased. At approximately 8:02pm, Warden notified Regional Director of the incident. Lieutenant secured cell S-11 with tape and the triage room in the Infirmary. Pictures were taken of S-11 and the triage room. At approximately 8:05pm, Law Enforcement Services Division Investigator was notified who advised the other agents were enroute.
