JOINT STATUS REPORT

Come now Plaintiffs Christopher Hampton and Cortney Rolley ("Plaintiffs") and Defendant Willie M. Burks ("Burks"), through undersigned counsel, and file this joint status report as instructed by the Court (Doc. 40) and state as follows:

- 1. On November 12, 2020, Burks filed a motion to stay this civil action pending the resolution of federal criminal civil rights charges filed against him in the United States District Court for the Middle District of Alabama, Northern Division, Case No.: 2:19-cr-344-MHT-JTA. (Doc. 20).
- 2. On November 17, 2020, Plaintiffs filed a response stating that there was no objection as to a stay for Burks only. (Doc. 22). Defendants Alabama

Department of Corrections and Warden Headley also filed a response indicating they did not oppose a stay as requested by Burks on November 30, 2020. (Doc. 31).

- 3. This Court held a hearing by videoconference on Burk's motion to stay on December 15, 2020 (Doc. 37), and ultimately granted the motions to stay by Defendants Burks and Bryanna Mosley but not as to the remaining defendants. (Doc. 39). This Court then ordered periodic status reports filed by Plaintiffs and Burks as to the status of criminal proceedings against Burks and Mosley. (Doc. 40).
- 4. Burks' criminal jury trial pending before this Court is currently scheduled for June 7, 2021. (*USA v. Burks*, No.: 2:19-cr-344-MHT-JTA (M.D. Ala.), Doc. 85).
- 5. Mosley's previously entered a plea agreement on May 28, 2019. (*USA v. Mosley*, No. 2:19-cr-00183-SMD-1 (M.D. Ala.), Docs. 8, 9), which was accepted by Judge Doyle that same day. Mosley's sentencing hearing has been continued generally (*USA v. Mosley*, No. 2:19-cr-00183-SMD-1 (M.D. Ala.), Doc. 16) and the status report she filed on November 26, 2019 was sealed at her request. (*USA v. Mosley*, No. 2:19-cr-00183-SMD-1 (M.D. Ala.), Docs. 17–19).
- 6. Plaintiffs and Defendant Burks jointly report that a limited stay as to Defendants Burks and Mosley is still appropriate pending the resolution of their criminal proceedings, and these parties will continue to provide periodic status reports as directed by the Court. (Doc. 40).
